### **World Payments Council**

Formerly the Governmental Relations Committee, the World Payments Council was established to actively monitor regulatory trends and policies that affect ATM deployers across the international marketplace. It is an international advocacy forum that works to develop / publish consistent positions representing the best interests of the broader ATM industry.



#### **ATM Cash Council**

The ATM Cash Council is a global committee open to all ATMIA members. Its mission is to portray the truth about cash by monitoring and reporting on global cash demand, circulation and usage today, while working to protect the freedom of the world's citizens to use cash.



### ATM Cyber Security Alliance

Chaired by ATMIA CEO Mike Lee, the ATM Cyber Security Alliance is a global group of industry security experts and law enforcement agencies, including the FBI, U.S. Secret Service and Interpol. The mission is to counteract current and emerging cyber-attacks on ATMs, and the committee is responsible for providing alerts, cyber security best practices and analysis of theoretical attacks.



#### ATM Security Forum @

The ATM Security Forum is designed to employ global security resources in a united alliance in order to protect the industry from criminal activity.



#### Consortium for Next Gen ATMs @

Chaired by ATMIA CEO Mike Lee, this is a movement of over 140 companies worldwide – across the full spectrum of sectors of the ATM value chain – committed to implementing a global blueprint for an API App Model for ATMs, including an architectural diagram of the blueprint and a 10-step plan to bring the project to fruition.

The Consortium has allocated responsibility for the 10-steps to specific subcommittees:

- Security Subcommittee is responsible for E2E security for the next gen ATM architecture.
- Standards & Technical Subcommittee is responsible for the architectural diagram of the blueprint as well as vendor-agnostic standards required for interoperability.
- Governance Subcommittee is responsible for coordinating and aligning goals of all subcommittees into one timeline of deliverables and for holding the Consortium accountable to its governing principles
- Customer Interface Subcommittee is responsible for customer interface best practices for the next gen ATM architecture and ecosystem, and a standard glossary of Next Gen terms.
- PR & Communications Subcommittee is responsible for coordinating the key internal and external messages of the Consortium, and for articulating its core business value propositions.



### International Marketing Forum @

The mission of the International Marketing Forum (IMF) is to promote communication between ATM industry marketing professionals, educate members on advances in marketing technology and techniques, and provide them with the information they need to more effectively promote their business.



## 2020 Committee

The mission of the 2020 Committee is to create an industry roadmap for migration to Windows 10 OS, including technical specifications and security requirements. The committee facilitates the long-range planning for the next big industry migration, well in advance of the end of support for Windows 7 in 2020.
