Approved Product List (APL)	A list of the state agency's WIC-authorized products
Automated Response Unit or Integrated Voice Response (ARU or IVR)	A designated system for answering telephone calls and providing information to callers via recorded messages, or for transferring calls to a customer service center. An automated telephone answering system can provide voice answers to questions using data from the WIC information system and/or the EBT system. For example, it can be used to remind clients of appointments, respond to balance inquiries, etc.
Broadband/Wild Card	A subcategory that allows the purchase of items in multiple subcats within a category
Category/Subcategory (Cat/Subcat)	Standardized way to identify foods
Cost Containment	Requirement for state agencies to implement specific measures to ensure competitive prices for supplemental foods.
Cost per Case Month (CPCM)	The fixed cost to deliver the mandatory category of services to a single case for one month and to operate the EBT system. Case is usually defined as an active case or an active account to which a benefit has been issued and made available for use in the month.
Cash Value Voucher or Cash Value Benefit (CVV or CVB)	A dollar-amount benefit for the purchase of fruits and vegetables as part of the new food package rule
Third Party Processor (TPP)	A company that conducts some part of a financial transaction process; especially a company that provides software or hardware for such a process

WIC MIS-EBT Universal Interface	A document that standardizes the functional requirements for the Universal Interface between the WIC Management Information Systems (WIC MIS) and the WIC Electronic Benefit Transfer systems (WIC EBT system) used in the Special Supplemental Food Program for Women, Infants and Children (WIC) nutrition program.
Value-Added Reseller	A company that adds features or services to an existing product, then resells it (usually to end- users) as an integrated product or complete "turn-key" solution. VARs incorporate platform software into their own software product packages.
Acquirer	Provides an entry point into transaction networks for all transactions (all tender types) from a store
Direct Connect	Transaction strategy that bypasses traditional payment networks
lssuer (aka Host)	Works on behalf of the state agency, holds client EBT accounts and authorizes redemption transactions
Gateway	Consolidates transactions from multiple acquirers on behalf of a host processor
Point of Sale (POS)	Entry point for EBT transactions in checkout lane
